*Minimum of 12 tanks and they ask that the tank be empty per DOT guidelines.

Recycling - Roto-molded (120 gallon) tanks

There are two ways we can handle these tanks.

1. The customer can access the Returnet site for returns of

CUSTOMER OWNED tanks

- •Returnet will pick up at your customers
- The pickup for cages is free.
- Your customer will be charged for each 120 gallon tank. Charge for recycling, charge for freight)
- Returnet asks for a 12 tank minimum between the two sizes.
- Any combination of the two sizes that equal 12 is good to go.

What if...

Q-The customer has 22 polycages?

A- Returnet picks up all 22 and there is not a charge to your customer.

- (Provided tanks are clean and empty)

Q-The customer has 12 cages and 6 asset tanks?

A-The customer would be charged only for the asset tanks on the load. [6 polytanks X \$\$]

Recycling Roto-molded tanks (Winfield Owned and Vendor Tanks)

- 2. Take an inventory of the sizes and products previously in the tanks.
- Take an inventory of vendor tanks that are being recycled.
- Contact/email Jay @ 319-752-6324 to arrange a pickup and delivery to recycling site.
- Vendors help pay for recycling of their tanks.
- By arranging our own transportation we save money!

Rinse Water -Handling

- Two methods
 - Waste Disposal
 - Beneficial Use
 - A third method water treatment?

Rinse Water for Disposal

- Collect all rinse water together, or
- Segregate rinse water (by crop, other)
- Set up profile for waste streams with waste disposal company
- Ship periodically depending on volume and type(s) of waste generated

Rinse Water for Beneficial Use

- Collect all rinse water together, or
- Segregate rinse water (by crop, other)
- Test (chemicals and concentrations)
- Agronomist recommendation or state protocol
- Field apply per recommended rates to appropriate fields
- In some cases get permit/approval from state agency
