
Georgia Pesticide Waste Collection Program: Clean Day

Georgia at a Glance

- Georgia has continued a clean sweep program since 1995 under the leadership of the Department of Agriculture
- EPA grants were used in the early years of the program which is now 100 percent state funded
- These collections, known as "Georgia Clean Day", have collected over 2,100,000 pounds of pesticides
- Beginning in FY 2003 the program has seen a steady cut in funding





Host Counties






Funding

- Over the past few years the funding for Georgia has been reduced from approximately \$225,000 annually to just over \$135,000 in FY 2005.
- Additional cuts occurred in FY2008
- Funding comes from the Georgia General Assembly

Collection Logistics

- The program is conducted in several single day events across the state. On-site pick ups are also conducted on an as needed basis
- There is no exchange program in place
- Pre-registration is encouraged but not required
- As a result of 9-11, the program has been opened up to anyone in the state with a pesticide disposal need
