Pesticide Disposal Assistance Program

- In 1980, NCDA&CS created the very FIRST Pesticide Disposal Assistance Program in the U.S. <u>This year is the 40TH Anniversary !</u>
- The Pesticide Disposal Assistance Program (PDAP) was established as a NON-REGULATORY Program to provide a legal and proper pesticide disposal option for farmers, homeowners, and institutions
- PDAP works closely with the Cooperative Extension and County-based Solid Waste/Recycling/HHW Coordinators in each County to conduct events



PDAP History

PDAP General Funding – Direct Appropriations

BEFORE 1st Multi-year contract (1980-1994) Contract cost = \$2.05 / lb & \$290 / drum

AFTER 1st Multi-year contract (1998-current) Original Contract < \$1.00 / lb & \$175 / drum Cost is NOT stagnant, but squeeze what we can

Each year after 1998 has been OVER 100K lbs

1999 Third person added

Direct Appropriations for Disposal remain \$150K / year for last 10-15 years ...

The Pesticide Environmental Trust Fund

In 1993, the North Carolina General Assembly enacted legislation creating the Pesticide Environmental Trust Fund (PETF).

This law requires companies registering pesticide products in North Carolina to pay an additional \$25 or \$50 environmental assessment fee for each brand registered with the N.C. Department of Agriculture & Consumer Services.

Companies must pay \$25 for products with annual sales less than \$5,000, and \$50 for products with annual sales \$5,000 or greater. Fees collected from this assessment are deposited into the Department's Pesticide Environmental Trust Fund.

NC Pesticide Law of 1971 General Statute § 143-468

(b) The Pesticide Environmental Fund is established as a non-reverting account within the North Carolina Department of Agriculture and Consumer Services..... The Department shall distribute money in the Fund as follows: (1) - (3) Twenty-five (25%) to enhance university agromedicine programs.

(4) Seventy-five percent (75%) to the Department of Agriculture and



Consumer Services for the cost of administering its pesticide disposal program, including, the salaries and support of staff for the pesticide disposal program, and for its environmental programs, as directed by the Board, including establishing a pesticide container management program to enhance its pesticide disposal program and its water quality initiatives.
